"A home inspection is a limited, non-invasive examination of the condition of a home, often in connection with the sale of that home. ... A home inspector is sometimes confused with a real estate appraiser. A home inspector determines the condition of a structure, whereas an appraiser determines the value of a property." Our property inspection surveys have been developed with SANS 10400 (The South African Bureau of Standards) as reference. SANS 10400 is deemed to satisfy minimum national standards for building in South Africa. APPROACH PROPERTY INSPECTION's survey and twenty-point report includes: Zoning and land use regulations; Structural specifications; Water supply and drainage; Electric hot water geysers; Solar water heaters; Glazing; Swimming pool safety; Handrails and balustrades; Waterproofing of buildings; Insect and pest infestation. Should the plans not be compliant, the seller will need to appoint an architect or draughtsman to prepare the plans for lodgement with the municipality.
